CHIEF APIARY INSPECTOR'S MESSAGE

I'm pleased to announce that Mr. Frank Cassidy of Mt. Sterling has joined our Apiary Inspectors Team. Frank will cover our west-central district, which includes the following counties: Adams, Brown, Calhoun, Fulton, Hancock, Henderson, McDonough, Mercer, Pike, Rock Island, Schuyler, and Warren. Frank is a very knowledgeable beekeeper and previously served with the Department as an Apiary Inspector. We are very pleased to have Frank back on board. Speaking of our Apiary Inspectors, our full team and I met on March 30, 2001 to discuss a variety of topics and to make plans for the current inspection season. Feel free to contact our inspectors if you need assistance. The Department's Apiary Inspectors and their telephone number are listed in this month's *ISBA Bulletin*. If you

are located in one of the Department's districts where the Apiary Inspector's position is vacant and assistance is needed, don't hesitate to contact any of our Apiary Inspectors, or me at (217) 785-4233.

I believe a few comments are in order regarding moving permits, which are required by the Illinois Bees and Apiaries Act. Please contact your Apiary Inspector for assistance in gaining the needed moving permit at least ten days before the actual movement (county to county, importation from other states, or moving bees out of state) of bee colonies or used bee equipment. Of course, this requirement is in place to protect bees from the potentially devastating effects of bacterial diseases and parasites. Your full cooperation will be greatly appreciated.

Active beekeepers from around the state have received notice from the Department in the past few months on annual registration of colonies. If you have not returned the form with the needed information, please do so as soon as possible. Similarly, if you have just entered the beekeeping business or have returned to beekeeping, it is critical that you complete, and mail to the Department a registration form to register your colonies. Registration forms may be obtained from your Apiary Inspector or from me. If you or someone you know has gone out of the business, please inform us of that also.

I'm writing this article during the first week of April and winter losses are being assessed by beekeepers statewide. The early reports that we received indicated heavy winter losses, in some cases 75%-100%. (Editor's note: A survey of 351 hives in the Heart of Illinois region showed a winter loss of 266 colonies, or some 76%.) If your apiary sustained above normal winter losses this past winter, I would appreciate receiving a short note from you on why you believe the loss took place and the degree of loss your apiary suffered. This information would be useful to the Department as we advise beekeepers on effective overwintering techniques and to the statewide records that we develop annually which are beneficial to beekeepers across Illinois.

The Department's Apiary Inspectors and I look forward to working with you this year!

#### ISBA SUMMER MEETING SLATED FOR JUNE 29 - 30

The ISBA summer meeting will be held as a joint gathering this year with the Indiana State Beekeeper's Association. The meeting, slated as a Friday-Saturday event, will be held at Purdue University, in West Lafayette, Indiana, June 29-30. There will be dinner on Friday evening, and an all-day session on Saturday. The three keynote speakers for the event will be Dr. Greg Hunt who will provide a research update at the Purdue University apiary at 3:00 p.m. on Friday afternoon, Dr. Jim Tew who will speak about "Experiences in Beekeeping" on Friday evening, and Ms. Sue W. Cobey who will speak about "Methods of Queen Rearing" beginning at 8:30 a.m. on Saturday morning. Following at 9:30 Dr. Tew will speak about "Beekeeping Trends."

During Saturday there will be two breakout sessions presenting three topics at a time. Session 1, beginning at 11:00 a.m., will deal with "Honey Plants and Pollination" (Mike Kotcher), "Improving Sales at Festivals and Fairs (Becky Vadas and Ron Fischer), and "Economics of Overwintering" (Carl Wenning). Session 2, beginning at 1:00 p.m., will deal with "Pollen: The Versatile Compound" (John Shane), "Improving Effectiveness of Your Local Beekeeping Club" (Rich Ramsey and Kenny Schneider), and "Gadgets and Gizmos/Classroom on Wheels" (Jerry Hayes). The day will conclude with an Open Forum for questions and answers with all speakers. Adjournment is set for 3:30 p.m.

Though the meeting begins on Friday afternoon, it is not required for any participant to attend the Friday sessions. This meeting is being co-hosted by the Cook-DuPage Beekeepers' Association (president Bill Buckley) and the Indiana State Beekeepers' Association (president Dave Laney) in cooperation with the Purdue University Department of Entomology. The detailed agenda for this two-day event will be provided in the next issue of the *ISBA Bulletin* (to be distributed in mid June) but is available now on the ISBA web site (*www.isba.ws*). Visit the ISBA web site regularly to see additional information that will be posted as soon as it becomes available.

#### BEES AND BEEKEEPING SHORT COURSE JULY 28 - 29

The fifth annual Bees and Beekeeping Short Course will be presented at the University of Illinois July 28-29. The short course will feature lectures, hands-on workshops, and informational discussions on a wide array of topics. In addition, there will be a bee experiment, "Birds-of-a-Feather" dinners, and French-style gourmet honey tasting. Speakers this year will be Dr. Mary Ann Frazier from Penn State University, Dr. Gene Robinson from the University of Illinois, Mr. Jerry Hayes from *American Bee Journal*, and members of the University of Illinois Bee Research Facility staff.

The short course will be held at the University of Illinois Student Union as well as at the Bee Research Facility, both of which are in Urbana, IL. The program begins at 8:00 a.m. on Saturday, July 28 and concludes at 1:00 p.m. on Sunday, July 29. A \$75 registration fee includes course materials, refreshments, and honey tasting. Lodging is available at the Hampton Inn for \$60 single/\$69 double, or air-conditioned dormitory rooms for \$20 per night (217-337-1100).

#### ISBE MEMBERS PROVIDE PUBLIC OUTREACH

ISBA members frequently provide service to the non-beekeeping public by setting out informational displays about honey, honey bees, and beekeeping. Now two Illinois Beekeepers have gone the extra mile to set out permanent displays. On Saturday, April 28, Carl Wenning helped Chief Naturalist Carol Thompson set up a two-frame observation hive in the nature center at Weldon Springs State Park which is located just south of Clinton, IL. Carol attended the HIBA beekeeping course this past February.

Kim Otto, another graduate of the HIBA beekeeping course, has helped Garfield Park Conservatory, in the heart of Chicago, to set up a honey bee program. Kim recently set out two hives there, and the conservatory is going to have two of its own hives. Garfield Park is a 184-acre site just 10 minutes from the Loop.

#### ISBA SPONSORS BOOTH

Over the March 10-11 weekend the ISBA sponsored a booth on behalf of Illinois beekeepers at the Illinois Products food expo. On March 10 Lincolnland beekeepers were represented by Rich Ramsey and Ken Beauchamp. On March 11, Steve and Jill Mayes and Tom Elston went to Springfield to represent Heart of Illinois beekeepers. There was a big crowd of over 3200 served by forty-eight Illinois vendors. The event provided lots of samples of free food. ISBA representatives talked about bees, gave out over 500 clover honey stix, handed out information and recipe brochures from the NHB and sold some honey. Fun was had by all.

#### BEEKEEPER OF THE YEAR NAMED

Harvey Seering, St. Clair Beekeepers' Association

At their monthly meeting in Belleville, IL, on February 23 the St. Clair Beekeepers' Association presented the 2000 Beekeeper of the Year award to Mrs. Josephine Christ. This award is in the form of a framed certificate. Mrs. Christ, who is ninety-three years old, said her first experience with bees was when her father had her walk between two rows of bee hives each day she went to school. He told her that this would make the bees accustomed to her, and that they would be less likely to sting her as a result.

At age nine, Josephine started helping her father work his bees. When she married her husband, Alvin, she got bees of her own. Shortly afterward, Alvin mowed around them with a team of horses. He bumped one of the hives and got stung. Alvin had an allergic reaction and broke out in hives, even on the bottom of his feet. Josephine said, "I was disgusted with him because I had never heard of anyone being allergic to bees, and he was mad at me because I had the bees. But I guess we got over it because we have been married for sixty-six years."

Josephine says seven hives is the largest number she has ever had at one time. She says that many years she extracted three to four hundred pounds of honey with a hand-cranked extractor. When her grandchildren got old enough, it became a party with each grandchild getting a turn at cranking the extractor. Josephine has not had any bees for the couple of years because she isn't strong enough to handle the hives any more. Nonetheless, she said, "Every spring I get the itch to get some bees. Then I tell myself, You can't handle them."

Even though she no longer keeps bees, Josephine is still active in the St. Clair Beekeepers' Association. She has served several terms as secretary of the association. Josephine says, "I volunteered to do that job to repay the association for all the good I had gotten from it."

Josephine and Alvin raised seven children, and have 39 grand-children and 48 great grandchildren. When one small grandson got interested in helping grandma extract honey, Josephine bough him some honey labels and filled some jars with honey for him. He then put the jars in this little wagon and went around his neighborhood selling honey.

Josephine and Alvin definitely are not stay-at-home senior citizens. Josephine would have received this award in November, but the couple was visiting their daughter in Alabama. Since then, they have visited a grandchild in Chicago, and on a recent Sunday Alvin helped some relatives make 300 pounds of summer sausage.

Everyone in the St. Clair Beekeepers Association is hoping that Josephine and Alvin can remain active in the Association for many more years to come.
