APIARY INSPECTION SUPERVISOR'S REPORT

Steve Chard, Illinois Department of Agriculture

Greetings! We hope all is going well with your bees.

Colony Collapse Disorder continues to be on everyone's mind in the apiary industry and in some circles outside the industry. CCD also continues to draw media attention, although less now as compared to a few weeks ago. While news stories are fewer in number, the scientific community is moving forward as quickly as possible with their research to determine the cause(s) of CCD. There are many theories on the possible cause(s), but nothing conclusive at this time. In spite of what you may have heard or seen on a national map, there have been no confirmed cases of CCD in Illinois. The national surveys that have been conducted have anonymous information, with no opportunity to follow up for confirmation. Regardless, all of us are continue to be very concerned about the ailment possibly emerging in Illinois and are closely monitoring this situation. If you believe your colonies may have CCD, please contact me at 217/782-6297 or your Department Apiary Inspector so arrangements can be made for an inspection.

While CCD is a significant problem, it seems all the media attention given to it has made the public in general much more aware of the importance of honeybees to humankind. Nowadays, when I receive swarm calls, and there have been many recently, most people ask what can be done to save the bees, instead of exterminating them. That is quite a change from last year. It's good to see some positives come out of the CCD issue.

On the good news front, most of the colonies we have inspected (routine inspections and for moving permits) thus far this year have been in good to excellent condition. There have been no large concentrations of varroa mites, American foulbrood, small hive beetle or chalkbrood. Small hive beetle is now also located in Logan County, bringing the to-

tal counties statewide with small hive beetle to 15. These continue to be in isolated spots in each county. Please continue to be on the lookout for the beetle, and report suspected finds to the Department so we can confirm whether the beetle is actually present.

Some more good news to share, Eric Shahlheber is now the Department's Apiary Inspector for the northwestern Illinois district, succeeding Lynn Osborn. Eric is a United States Air Force veteran, a beekeeper, soon to be married and is anxious to work with all beekeepers in his district. In addition, the Department's Apiary Inspector's position in our southern district continues to be vacant.
